"Loosening Our Grip": Minister's Annual Report 2013

Although he's been dead for almost a century, the German poet Rainer Maria Rilke remains one of the best-selling poets in North America. Rilke was an extraordinary Christian mystic. Consider this simple observation:

We need, in love, to practice only this: letting each other go.

For holding on comes easily; we do not need to learn it.

Like so much of life, Rilke's advice is profoundly simple, but not at all easy. In fact, whole religious systems are based on this plain thinking: that the human tendency to cling is the source of so much of our suffering. But to truly live out Rilke's wisdom requires maturity, discipline, and humility.

As the Christian church undergoes profound change in our part of the world, we'd do well to listen to Rilke. Think about it: as the cultural influence of the Christian church wanes, we can react with tenacious clinging. We can hold on like grim death, insisting steadfastly on our own righteousness. Or we can hold our truth lightly—with grace, generosity, even with playfulness. We can choose how we will treat the Christian witness: as an heirloom legacy meant to be guarded, or as a durable treasure to be shared.

I love our Trinity church family—so much that I probably don't see us with scientific clarity. But what I experience is a community that is in the process of letting up, opening up, loosening up—in all the right ways. It's subtle: a more relaxed attitude to worship, a growing openness to the arts. An increased tolerance for the unexpected, for noise and whimsy and even for mischief. A desire to linger and listen and laugh; to connect, to understand, and to practice compassion. I see in these subtle changes a more trusting and down-to-earth faith. A suspicion that the Gospel doesn't need to be pampered, fortified, safeguarded, or squirreled away.

Jesus once spoke a simple poem not unlike Rilke's:

If you would save your life, You will merely lose it;

But if you would give up your life for the sake of good news,

How very much will be saved!

Our church family is perhaps just learning to embody the advice of Jesus and his merry mystics—to let go, to open up, to trust God, and to trust the world. Thank you for that learning, thank you for that sharing. Thank you for the many lessons of 2013!

From the Intern Minister

I arrived in North Bay in late August 2013 with much excitement and thrill in my heart. Trinity United has a strong history of learning relationships with student ministers. I knew before I arrived that I would like it here, not because of the reports I read, but because Trinity has a solid reputation among students across the country for being a good learning site.

The learning that takes place in internship sites is vastly different from the academic preparation a student spends a few years acquiring before arriving. The learning relationship is vital for a student to learn, explore and identify their strengths and weaknesses in a congregational setting with support and freedom to experiment. Trinity has made all that possible with ease. Trinity is a place that one can be 'dropped' into and thrive easily.

While here, I have attended as many functions as possible to know the congregation more intimately. What a way to be introduced to a church by making hundreds of apple pies! Trinity's rich and vibrant presence in the community is known and felt in everything we do from pies, to Longest Night, The School of Yule put on by Trinity Arts, the vibrant youth functions, to our monthly UCW lunches. The hospitality shown here in the Food Shelf, the Mother's Group, UCW, AOTS, Scouts and everything we are facilitating or hosting, is the Gospel in action. I have learned a lot from this environment, the people, my supervisors and the other people I work with. Trinity is a jewel of a church, made so by excellent people and their respective leadership inspired by the Holy Spirit.

Sadly, changes to the internship program mean changes in where and how students will be placed in the future. While this is an important step in making sure both churches and students have their needs met, it also means that fewer churches will be able to afford a student. Trinity's future as an official learning site may not be possible. And with

that, I realise that I will probably be the last student to have an internship Trinity. So, in some senses, this report is a time capsule for future people to have a snap shot of what student ministry looks like in 2013-14.

Being a student minister requires a humility and vulnerability to truly explore with intimacy, those aspects of ourselves that need refinement, clarification, encouragement and honest feedback from others. Learning of this type requires taking risks not knowing the outcome. Student ministry can be filled with both affirmations and challenges. Trinity has gracefully and with holiness, risen to the occasion to shape and mold their students. I am very fortunate and savour my moments here, because I know not all churches are as vibrant and healthy as Trinity. Being at Trinity will provide a solid base for my future ministry in however God calls me to live my vocation.

In the few months I have been here, I have witnessed what it means to be a Baptizing Community, rich with expression of faith, journeying with and in Christ accompanied by the Holy Spirit. Trinity, the church built on a rock, will also be the rock that my foundations of ministry will be built upon.

Property and Grounds Committee

Another busy year has come to an end and again the members of the Property and Grounds Committee have been active.

Our "Spring Spruce Up" saw a keen group of Church Members attack the outside of our building with brooms and paint brushes and we successfully swept and painted the stone foundation grey and the window lintels white, making the outside look clean and tidy. We would like to fix up the outside of new part of McIntyre Street, which would involve painting the exterior of the Ministers Office and the area above it.

Repairs where made to the front brick caused by our Lightening Strike and the weather which saw hundreds of bricks replaced with the cost split between the Church and our Insurance People.

During the summer, with a generous donation from a Church Member and some assistance from Church User Groups our Committee refurbished the washroom and floor in the Nursery. The washroom is now accessible to all and has a change table for babies available as needed.

Final approval by the Fire Marshall for our Fire Upgrade Project was greeted with great relief by all. He declared we where now compliant with current Fire Safety Standards. A huge Thank You goes out to all who participated in this costly undertaking. We



also added magnetic hold back devices on 4 doors in the lobby to make it easier to access the building through some heavy fire doors.

Nancy Dewar Stenning created a magnificent mural in the play area of the Nursery. It is a spectacular piece of work, which brings enjoyment to all who have stopped to view the bits of Trinity Trivia placed inside her creation.

Our team has also assisted in the setting up of our Sunday School Room for untold meals and events under the guidance of Stephen Hutchison who makes all the phone calls.

Recently we changed a number of light fixtures in the Sunday School Room and in the Narthex to modern T8 energy efficient lighting thanks to a gift from Bob Jackson.

All of these projects are completed because of the hard work of many individuals who contribute funds or help with the actual work. I again would like to personally thank Don Rideout and Tony DePencier for all they contribute to our Building and Grounds Committee.

Our Future Plans include the creating and installation of a portable stage for the Sanctuary for which we had a successful fundraiser at our "School of Yule" show in December. During the summer vacation time we plan to install an improved video security system for both daytime and Sunday Church monitoring. We will be replacing the Narthex roof and repairing the interior ceiling of the Narthex as soon as the weather warms up. Our summer project will be refurbishing (cleaning, painting and rearranging) the original Board Room of the Church off the right hand door of the Sanctuary.

Again, thank you to all who pitch in with financial and physical assistance, it is all greatly appreciated.

Presbytery Representatives Report

Our North Bay Presbytery includes representation from the United Churches in Sturgeon Falls, Redbridge, Mattawa, Rutherglen, Callander, Loring, Golden Valley, Restoule, Nipissing, Powassan, Trout Creek, South River, Sundridge, Magnetawan, Burks Falls, Katrine, Temiscaming and, of course, North Bay. Trinity United Church has three representatives (based on membership numbers), Janice Brownlee, Don Haslam and Eunice LaPorte. Ann Clark very generously fills in as an Alternate if and when required. Presbytery also includes all paid accountable ministry staff (Rev. Ted and Lisa Blais), retired members of the Ordered Ministry (Rev. Kathy) and up to 10 lay members at large. From our congregation, Bill Brownlee is a member at large. It should also be noted that Marcel MacDonald is the coordinator for the Youth Connecting with Youth initiative.

Presbytery has an Executive and four Standing Committees – Finance, Mission, Ministry Personnel and Education (MP&E) and, Nominating; these committees meet monthly (except July and August) and then report to the 'full court' that meets four times per year – typically September, November, February and April.

The work of Presbytery includes (but is not limited to): over-sight every three years of each Pastoral Charge, ensuring supervision of unstaffed churches, receiving Annual Reports and monitoring financial status, promoting

Mission activities, approving closures and changes in staffing (appointments and settlements), licensing and education of Lay Worship Leaders, assisting with Joint Needs Assessments and, is a conduit of information to the Manitou Conference. Another primary role of Presbytery is to provide a forum for learning, networking and worshiping together. Presbytery is there as a support to the congregations providing assistance as requested.

The Youth Connecting With Youth (YCWY) program has continued under the enthusiastic leadership of Marcel MacDonald. Events are offered on a monthly basis and attended by youth from across the Presbytery. The main host church for these events has been Chalmers in South River, however other churches have also had the opportunity to welcome the youth.

Presbytery news continues to be shared monthly thanks to the work of Carol Martin from the Mattawa/Rutherglen Pastoral Charge. "The Ties That Bind" keeps us connected to each other by publishing events that are happening in the various pastoral charges. Lisa is our contact person so if you have anything that you think would be of interest to the Presbytery, talk to her. Copies of the newsletter are usually on the table outside Wanda's office or if you would like to receive it by email speak to Lisa.



Vacation Bible Camp

A feasibility study to see if there is a need for chaplaincy services at the University/College complex was completed inn the spring of 2013. The report including recommendations was reported to the court of Presbytery in September. The Presbytery agreed to proceed in working with the University/College to establish this chaplaincy service. The work continues.

Rev Jon Bok Kim has come to Knox United, Callander and Omond United, North Bay in a shared ministry with the 2 churches.

Circa 1915, four North Bay churches, Trinity United, St. Andrew's United, Calvin Presbyterian and First Baptist joined together and established Union Cemetery which, thanks to many dedicated volunteers, has faithfully served the local community ever since. The cemetery functions under the Cemeteries Act of Ontario. It also maintains its own Rules and Regulations, which may be amended from time to time to meet Minister of Consumer and Commercial Relations guidelines. The Cemetery is financially self-supporting with the exception of an annual \$200.00 donation from each of the four churches.

The Cemetery's revenue is derived from plot sales and burial fees and the proceeds are used to pay all operating expenses including facility maintenance and perpetual care. Any excess funds are held in trust in accordance with the Cemeteries Act.

The current members of the Union Cemetery Board are: Henry Drenth - Chairman (Calvin), Everette Armstrong - Secretary (1st Baptist), Ted Thomson (Calvin), Stuart Bailey (St. Andrew's), Rob Brownlee - Treasurer (Trinity), and Ross Brewer (Trinity).

Trustees Report

The Board of Trustees is entrusted with those matters related to the fixed and fiscal property of the Congregation in accordance with the United Church of Canada Manual.

In carrying out these responsibilities the Trustees ensure that the church building and its contents are adequately insured, and that sufficient comprehensive insurance coverage is carried to protect the Congregation and the Staff against personal liability arising out of actual or alleged claims of negligence or damages. The Trustees are also charged with the prudent investing of funds held in Trust on behalf of the Congregation. The Trustees meet on an "as required" basis.

In 2013, an annual review of Trinity's insurance requirements was conducted and the coverage was renewed resulting in a cost savings of \$138.00 per month. In April, Trinity's sole remaining investment (funds from the sale of the Manse) matured in the amount of \$79,766.00. Given that the outstanding balance on Trinity's Capital Assistance Loan from the Mission and Service Fund (for Fire Safety Upgrades) was still approximately \$32,000.00, the Trustees approved a long-term investment of \$50,000.00 and retained \$38,000.00 in short-term investments to cover possible year-end shortfalls and loan repayment options.

In June, the Trustees received notification that two bequests from a former Trinity member would be forthcoming. Two amounts were designated; one for "Trinity United Church Projects", and one for the "Trinity United Church Food Bank". Because the designated amounts are substantial, the Trustees considered how these funds might be administered. With regard to the "Projects" funds, the Trustees felt that sufficient checks and balances already exist within Trinity's current Board and Committee system, and as there is a requirement for project approval by

the Estate Trustees (as stipulated in the Will) no changes would be required to effectively manage these funds. However, there was considerable discussion regarding the governance of a large infusion of money into the Food Bank which is not represented by an official Committee of the Board. It was concluded that a Food Bank Committee with proper signing authorities was needed to deal with this increased scale of fiscal responsibility, so the Trustees recommended to the Board "that a committee be established to oversee Food Bank operations and to manage the funds designated for the Trinity Food Bank".

For 2014 the Board of Trustees will consist of Ross Brewer, Gladys Mae Banks-Bryer, Bob Cooney, Jim Liddell, and Ed Rose. In addition we welcome Sandra Rozicki as the newest member to our Board. On behalf of Trinity, and the Board of Trustees, I would like to acknowledge the efforts of Peter Moseley-Williams and Roman Rozicki who are retiring this year. We thank them for their dedicated service for the past five years.

Trinity Arts

Membership:

Our flexible and open membership has primarily included Rod Carley, Nancy Dewar-Stenning, Darlene Laferriere, Lisa Blais, Rev. Ted.

Mandate:

'Using the many blessings of the Trinity church family to enrich life and faith through the arts.'

Trinity Arts was formed many years ago as a vehicle to enable the sharing and enrichment of the arts at Trinity, and for the wider North Bay community. Effectively making the arts a part of Trinity's mission outreach enabled artists (often artists on tour) to use Trinity's facilities to perform in North Bay in a way that is practical, affordable, and enriching to the community. Events included organ recitals, concerts, visiting choirs, and drama productions.

In recent years, Trinity Arts has enjoyed a looser mandate as well as shifting leadership—concentrating more on "homegrown" productions, local talent, and projects for which our leadership has passion and interest. Events have included visiting musicians and speakers, drama groups, a winter talent show, and Christmastime fundraisers for "The Gathering Place."

Trinity Arts in 2013: Projects in 2013 included the Trinity Coffeehouse in January (raising \$705 for the Mission and Service Fund), "The School of Yule" in December (raising approximately \$1795 for "the Gathering Place"), and hosting the Ottawabased "Faith and the Arts" troupe in September.

Appreciations: Every "Trinity Arts" project is a testament to the enthusiastic spirit of 'pitching in' at Trinity! Members and friends of Trinity are regularly called upon to plan, volunteer, host, practice, bake, act, sing, build, design, sell tickets, share posters, wash dishes, serve coffee, and clean up! We could never do it without our large and caring church family. Because of you, "Trinity Arts" has a negligible budget, and generally give our profits away to causes like "The Gathering Place" and the United Church Mission and Service Fund.

Future Plans: Members of "Trinity Arts" are excited about continuing our two winter traditions: the "Gathering Place" fundraiser for Christmas 2014 is likely to be another "Christmas Carol" reading, and the midwinter "Trinity Coffeehouse" has definitely become a beloved Trinity mainstay! A new stage is under construction for the use of "Mustard Seed" and Trinity Arts. Also, we are looking ahead to developments which will make 2015 "The Year of Lear" at Trinity—stay tuned!

Sunday School Survey Results

A survey was conducted online last year to assess the Sunday School Program by both the Children and the Teachers. A brief summary of the results is included below.

Sunday School Student Survey

- 15 children ages 3 and older completed the survey – all responded favourably to our Sunday School program
- They identified their favourite activities as cooking (83%); they also enjoyed games, crafts, drama, listening to the story and music as favourite activities as well

Sunday School Teacher Survey

- 10 teachers responded to the survey
- The Sunday School curriculum was identified as being effective and appropriate overall for the children
- Teachers identified that they sometimes need more material and/or support for the lessons, especially when church services run longer or parents/caregivers are late picking up their children
- Teachers identified that it can be difficult to keep younger children engaged and that sometimes they find it challenging working with children who are high energy

 Teachers responded that the most rewarding part of teaching Sunday School was being able to instill a love for God and hearing children express their faith. They find it meaningful getting to know the children and sharing bible stories and life lessons with them.

Actions to be implemented as a result of the survey

- We will do our best to ensure that teachers have all the materials they need to keep the children engaged should the Church Service run longer than expected
- We will communicate concerns with the parents and caregivers if a child is having difficulty in the class and remind them to come as promptly as possible to pick up their children
- We will do our best to ensure that every 3 week rotation includes a cooking rotation
- Materials and supplies will be clearly labeled and available for teachers to access for their lessons

Trinity Families

Over the course of 2013, Trinity families has organized eight activities, although, the group strives to do one activity per month. The groups' mandate is to provide fun family-friendly activities that are affordable and accessible to everyone. Trinity Families acts as an out-reach to new families interested in joining Trinity.

There is a Facebook page where we share information about the activities of the group, the wider church and the community. It is also a place to post pictures and give parents an opportunity to network and find baby-sitters. You can find us by searching Trinity Families on Facebook and asking to join our group.

There's been an influx of new families to Trinity and we've made sure to make them feel welcome and give them information and invitations to the group and its activities.

Trinity United North Bay is blessed with having a strong and active men's group. A church where so many men are involved in all aspects of church life is uncommon and requires celebration. The church becomes even more richly served when the men are active in a group where fellowship and service form the foundation of a strong organization. It has been my privilege over the past year to serve as the President of our AOTS, leading our 44 registered members.

A strong and vital men's ministry in a church ensures that our ministry team can quickly find a group to do some heavy lifting. But more importantly, the church can be assured that there is a strong group of role models for the young people in our congregation as well as in the community. To ensure that our presence is noted both the church but as importantly, in the community, our group purchased embroidered jackets. Thank you for your generous donations to Trinity in 2013. Our donations fell short of our budget requirements by more than \$25,000. Fortunately our fundraising was more than required and our spending was less than expected. We end up this year about \$10,000 in deficit. Interestingly the cost of the improvements to the lift was about \$10,000. Our extra fundraising for 2014 must include the lift expenses and the narthex roof which will be completed early in this year.

The members of the committee were: Donald Bell, Bob Cook, Eunice Laporte, Moe Laporte, John Roberts, Bill Brownlee with seconded members Wanda Gleason, Envelope Secretary and Treasurer, Peter Moseley-Williams. Eunice Laporte moved to another committee about halfway through the year.

Thanks to Moe Laporte for organizing the tellers and the ushers who counted and deposited the offerings during the year. And thanks also to all who agreed to help in this way. Also thank you to all those who helped with any of our fundraisers.

Once again we have given generously to our outreach projects. The Finance report shows \$27,342.00 to M&S but to this we can add extra non budgeted amounts of \$1079.00 to the Food Shelf, Advent Offerings of \$2564.00, \$1795.00 for the Gathering Place, \$5608.00 for special appeals and several other donations you can find in the Annual Financial Reports. Trinity has again proven to be an extremely generous congregation. Thank you.

This is a very active congregation and we have enjoyed meaningful and enjoyable community in our activities as is demonstrated in the other submissions in the Annual Report. If you have not found your

niche here yet perhaps the activities of these groups will pick your interest, We have completed a number of projects this year including the brick work and a family accessible washroom as well as safety improvements to the lift.

We continue to be grateful for the UCW. With support of many in the congregation, they have been able to contribute a significant amount toward outreach as well as the general needs of the congregation. Where would we be without the ladies?

We have about 100 supporters on PAR Whose donations amount to almost \$10,000 per month. This is an amount we can count on each month so is a great help in paying our way. Despite our financial difficulties we have had another great year as portrayed in the reports in this document. Thank you!




